Florida Prepaid Tuition

- You are not required to notify our office that you want to use your Prepaid plan. Our billing system links to Florida Prepaid with your SSN.
- Your Florida Prepaid will reflect on your fee invoice by the first day of classes.
 - If your Florida Prepaid is not showing prior to the Payment Deadline, please contact Student Account Services for assistance at <u>tpbilling@ucf.edu</u>
- UCF will automatically bill Florida Prepaid for the number of hours in which the student is enrolled.

Payment Plan

- Available in myUCF portal
- Link to opt in is available at the beginning of the second week of classes
- There is a \$15.00 mandatory processing fee
- 50% of total tuition and fees is due upfront
- Students with financial aid, Florida Prepaid, waivers or third-party payments are NOT eligible for the plan.

Payment Deadline

- The payment deadline date is published on the <u>Academic Calendar</u> online at <u>calendar.ucf.edu</u>.
- The tuition and fee payment deadline is also posted to the student's <u>Fee</u> <u>Invoice</u> in the myUCF portal (*Student Self Service > Student Accounts > Fee Invoice*).
- Students with an authorized <u>deferral</u> may see the due date on the fee invoice adjusted after the term's add/drop period.
- *Late Payment Fee: \$100.00 (If not paid by the fee payment deadline listed on your Fee Invoice)
 - Additional penalties may be applied for reinstatement, if Dropped for Non-Payment.



Applying/Transferring for Financial Aid

Free Application for Federal Student Aid (FAFSA)

- Required for most federal, state and institutional aid
- FAFSA is available each year on October 1^{st.}
- UPDATE the FAFSA to include our school code, 003954.
 - Select the appropriate school year
- UCF's priority filing date is Dec 1st!





FAFSA: Citizenship Question

- Citizenship status. This question cannot be left blank.
- Select the option that indicates your citizenship status.
- You must select the option that indicates your citizenship status.
- Select U.S. citizen if you are a U.S. citizen or U.S. national.
- Select Eligible noncitizen if you are:
 - A U.S. permanent resident, with a Permanent Resident Card (I-551), or a conditional permanent resident with a Conditional Green Card (I-551C)
 - Other eligible noncitizen with an Arrival-Departure Record (I-94) from the Department of Homeland Security showing any one of the following designations: "Refugee," "Asylum Granted," "Parolee" (I-94 confirms that you were paroled for a minimum of one year and status has not expired), T-Visa holder (T-1, T-2, T-3, etc.), or "Cuban-Haitian Entrant"




