Florida Prepaid Tuition

- You are not required to notify our office that you want to use your Prepaid plan. Our billing system links to Florida Prepaid with your SSN.
- Your Florida Prepaid will reflect on your fee invoice by the first day of classes.
 - If your Florida Prepaid is not showing prior to the Payment Deadline, please contact Student Account Services for assistance at **tpbilling@ucf.edu**
- UCF will automatically bill Florida Prepaid for the number of hours in which the student is enrolled.
 - Students wanting to cancel or adjust billings for a specific term must update the hours to bill in their myUCF prior to the end of the term's add/drop period. For instructions, please visit https://studentaccounts.ucf.edu/florida-prepaid/
- Fees not covered by the plan must be paid out of pocket or covered by other sources.



529 Savings Account

- Please contact your 529 investment firm to use these funds
 - These are <u>not</u> considered third party billing.
- 529 checks can be mailed to Student Account Services.
 - Please ensure your student's name and UCFID are on the payment, as well as what the payment is for.
- A student may incur late fees and may be placed on financial hold if the payment is received after the payment deadline.



Tuition Deferment

- Financial Aid
- Florida Prepaid
- Third Party Billing
- Waiver

Tuition may be deferred to a later date. To view: Access your myUCF to view your fee invoice and click on "Due Charge," to view if your tuition is deferred.

- Deferment is not guaranteed
- Student is fully responsible for payment by "Due Charge" date

Payment Plan

- Available in myUCF portal
- Link to opt in is available at the beginning of the second week of classes
- There is a \$15.00 mandatory processing fee
- 50% of total tuition and fees is due upfront
- Students with financial aid, Florida Prepaid, waivers or third-party payments are NOT eligible for the plan.

Direct Deposit (highly recommended)

- Student's bank account; any U.S. financial institution
- Student's name must be on the account
- Student must sign up on myUCF (2-part process)
 - Student Self Service >Student Center >Student Direct Deposit







Federal Direct Loans

- Not credit based
- 6-month grace period (a period when a student is no longer enrolled for at least half-time and not required to make payments)
- Fixed interest rates
- Can begin to accept in July on myUCF

Subsidized Loans

- Government pays the interest
- Need-based
- Undergraduate students

Unsubsidized Loans

- Interest accrues immediately
- Independent students may be eligible for greater unsubsidized amounts



Federal Direct Parent PLUS Loans



First Year

Experience

- The Federal Parent PLUS Loan is a credit based federal loan for parents
- Interest that accrues on the loan is not subsidized by the federal government
- Application process begins each
 July

Florida Bright Futures

- Determined by the State of Florida Office of Student Financial Assistance (OSFA).
- UCF must be identified as your post-secondary institution on the Initial Student Florida Financial Aid Application (FFAA).
- Bright Futures is awarded on a per credit hour amount.
- Bright Futures funds up to 120 credit hours.

100% of tuition and applicable *fees = \$212.28

Florida Medallion Scholars

75% of tuition and applicable *fees = \$159.21

*Applicable fees include activity and service fee, health fee, athletic fee, financial aid fee, capital improvement fee, campus access/transportation fee, technology fee and tuition differential fee.



Deferment

- Extends payment for tuition & fees
- Based on the amount of the student's anticipated and accepted financial aid for the term
- Not all financial aid are included for a deferment
 - Federal Direct Loans <u>must</u> be <u>accepted</u>, <u>decline</u>, or reduced from your myUCF to be included for a deferment
 - Work-study <u>does not provide</u> deferment as student earns paycheck every other week



"To Do" List

- Confirmation of an academic activity occurs every semester.











Maintaining Your Awards






Maintaining Awards

Satisfactory Academic Progress (SAP)*

- Reviewed at the end of each term
- Students must complete 67% of credit hours attempted
- Students cannot exceed 150% of the credits required to graduate
- Students must maintain a 2.0 cumulative GPA.
- Courses must be towards program completion.





Special Circumstances


- Change in employment status
- Medical expenses not covered by insurance


